FEMA To Mobilize For "Mass Fatality Planning"

October 5, 2012--The United States Congress has passed a bill which mandates the Federal Emergency Management Agency (FEMA) to prepare for "mass fatality planning" and funeral homes, cemeteries and mortuaries being "overwhelmed" in the aftermath of a mass terror attack, natural disaster or other crisis.



The bill, H. R. 6566 or the Mass Fatality Planning and Religious Considerations Act, was [posted on the govtrack.us website this morning](#) having been approved by the House on September 28.

The legislation amends the Homeland Security Act of 2002 to direct FEMA to **"provide guidance and coordination for mass fatality planning, and for other purposes."**

Noting the necessity for emergency preparedness in relation to terror attacks, natural disasters and man-made disasters, the bill instructs FEMA to be sensitive to the fact that Jews and Muslims require bodies to be buried within 48 hours of death.

"Funeral homes, cemeteries, and mortuaries could be overwhelmed should mass fatalities arise from a natural disaster, act of terrorism, or other man-made disaster," states the legislation.

FDA Approves Sale of Pills With RFID Microchip

Big Brother is watching – RFID Microchip pills have now come to the United States. [Beginning and End](#) covered the [United Kingdom approving prescription pills that contained RFID microchips](#). Now the United States Food and Drug Administration has approved similar ingestible RFID microchip medicine for use in the U.S.

The Food and Drug Administration has approved an ingestible digital sensor that can track physical health with the assertion that patients are not taking their medication regularly and need a tracking device inside their body to assist them in their medical care... Proteus Digital Health (PDH) released the Ingestion Event Marker (IEM) which was first approved in Europe. George Savage, co-founder and chief medical officer at PDH claims that this ushers in a new era of digital medicine that "shifts the paradigm." **The IEM, as small as a grain of sand, can be embedded in a pill, and ingested to monitor the patient and their bodily health. The device will collect measurements such as heart rate, body position and activity.** The IEM sends a signal to your smartphone; which then transmits the data to your doctor. Actual real time data about your biological make-up can be uploaded wirelessly. ([source](#)).

The RFID chip in the pill is being offered to help patients be more efficient with their medicine. As *Beginning and End* has detailed, society is becoming more and more indoctrinated into the acceptance, use and desire of RFID microchips as a regular part of life. **All the while the dangers of the intrusion into one's privacy are not taken into account as serious issues.** Even those in favor of the RFID pills openly acknowledge the privacy issues involved: "About half of all people don't take medications like they're supposed to," says Eric Topol, **director of the Scripps Translational Science Institute** in La Jolla, California. Now "big brother" will have a person's full medical profile, current health status and location all stored on a computer network and tracked real time.

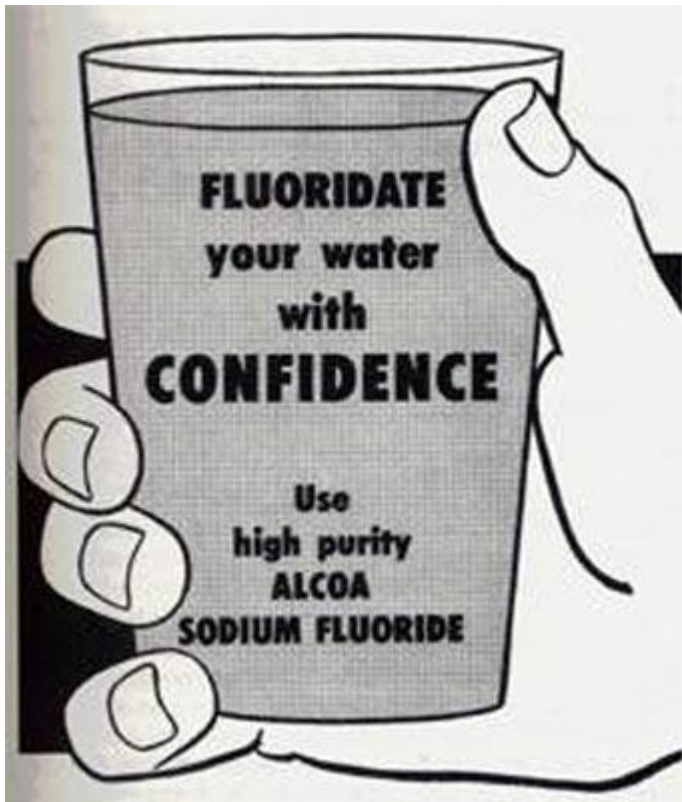
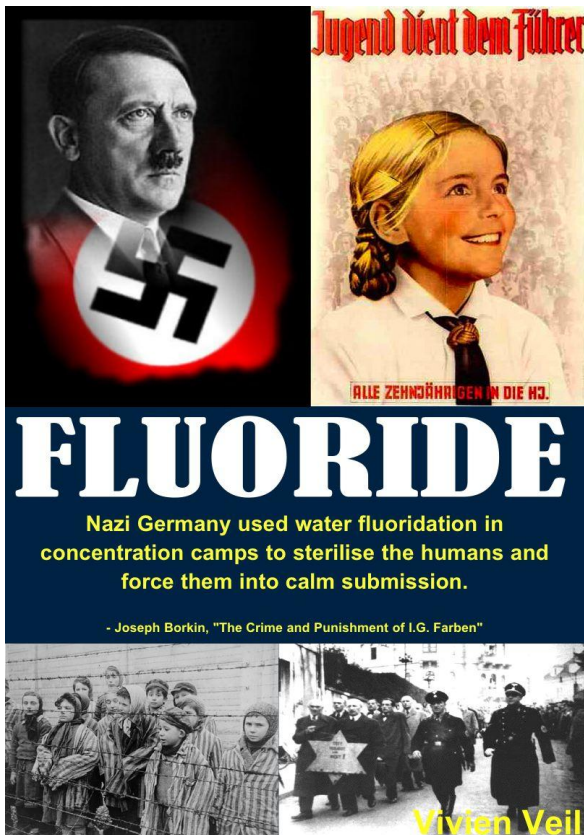
Fluoridate the salt? Of course. Just like they did at German concentration camps.

A Brief History of Fluoride

*In 1945 local water treatment facilities began to add sodium fluoride to our water supply. The first thing you should know is that the sodium fluoride they put in our water is **not** a pharmaceutical grade additive.*

Sodium Fluoride is an industrial waste byproduct from aluminum manufacturing. As aluminum production increased in the first half of the twentieth century, **it became necessary to find somewhere to put the deadly, caustic, toxic fluoride.** **Manufacturers could no longer get away with dumping it into rivers or landfills, because it was poisoning crops and killing livestock and aquatic life.** So **Francis Frary** (chief scientist for ALCOA) had an idea. He commissioned **Gerald Cox** at the Mellon Institute **to conduct research regarding the benefits of adding fluoride to the water supply.** **The Mellon Institute was frequently hired by big business to produce research that supported their industries, and for several decades they produced research showing that asbestos was safe and did not cause cancer.**

Another proponent of the safety of fluoride at that time was scientist **Harold Hodge**, who was later revealed to have **been part of the the Human Radiation Experiment; injecting test subjects with plutonium and uranium in 1945-46.** This was documented by Pulitzer prize winning reporter **Eileen Welsone** in [The Plutonium Files](#).

Hodge was also chief toxicologist of The Manhattan Project and fluoride was a key component in the production of the atom bomb. His studies were conducted with a bias toward proving fluoride safe, which would protect the government and industry from lawsuits. [More](#)

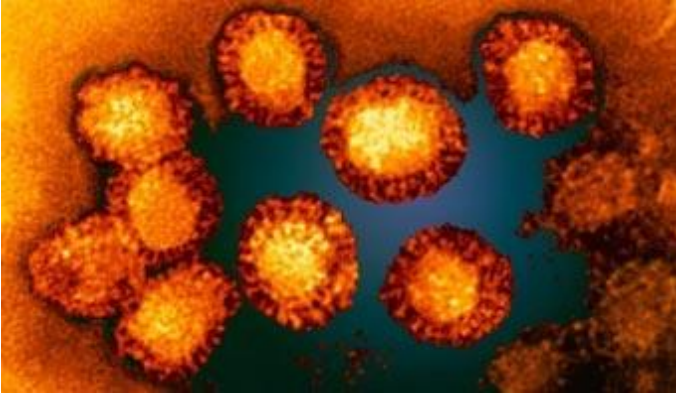

West Nile Virus “Outbreak” Justifies Spraying Toxic Chemicals onto Citizens

Susanne Posel-- The Centers for Disease Control and Prevention (CDC) state that the cases of West Nile virus (WNV) are raising to the point of having the largest outbreak ever seen in the domestic US. In total, the CDC is reporting 1,118 cases with 41 deaths attributed.



Yet the CDC claims that most bitten by an infected mosquito do not come down with WNV (Comment: This is what a strong “God-given” immune system can do for us). It appears the governmental agency fear-mongers and downplays the threat in the same breath.

In a 2002 Congressional testimony, Dr. Leonard Horowitz, said that the makers of WNV vaccines were suspected of participating in the actual public outbreaks of WNV in the Middle East.

By combining CDC reports, with the documentation of pharmaceutical corporations, and bioweapons laboratories(that supplied vials of WNV to Iraq in the 1980s) the movement of the bioweapon has been traced.

Hospital Employees' Will be Fired If They Don't Get Flu Shot

DENVER (CBS4)- Hospital employees across Colorado are being threatened with their jobs if they don't get the flu shot by the end of the year.

Fragments of foreign DNA and other substances from vaccinations found in sick, disabled and dying children

This week an important paper by Leslie Carol Botha hit the Internet by storm. The "Rotarix vaccine contained nucleic acids from porcine circovirus-1 (PCV1), virus.¹ Since this report, a second rotavirus vaccine (RotaTeq) has been shown to contain nucleic acids from both PCV1 and PCV2, **a pathogen in pigs that is associated with wasting and immunodeficiency.**"

Both of these vaccinations are given to infants to supposedly protect them from the rotavirus. The rotavirus vaccine is a vaccination given to infants aged 2, 4 and 6 months. **Botha's research is clearly stating that DNA from pigs is being found in rotavirus vaccine with the potential to cause wasting and immunodeficiency. Yet when evidence of this discovery was presented to the FDA back in 2010 the FDA announced that it was no problem!**

Chinese Drywall Warning

Background: Over 3,000 homeowners have reported that drywall imported from China has caused health problems and metal corrosion in their homes. The Chinese Drywall warning refers to defective or tainted drywall imported from China from 2001 to 2008 which emits sulfur gasses which usually (but not always) create a noxious odor and corrode copper and other metal surfaces, thereby damaging your air conditioner, electrical wiring, copper plumbing, appliances and electronics. Chinese drywall can also cause adverse health effects.

This time period unfortunately coincides with the housing boom and drywall shortage.

While the material source of the problem is known, a complete understanding of the cause of the problem remains unknown, which is likely due in part because different mines were involved, there were different manufacturing processes, and different types of construction and building materials were used.

Original focus was that this was going to be seen just in Florida, but now as seen in papers and on the news is being found elsewhere.

Issue: Due to components of the drywall (elevated levels of sulfur) it is causing corrosion of copper wiring (turning black in the panel), A/C unit coils to corrode/fail, tarnishing jewelry, door stops to tarnish and turn black, and can even shorten the life of TV's and microwaves due to internal corrosion.

Health Concerns: The possibility that the Chinese drywall is emitting excessive amounts of hydrogen sulfide fumes and ammonia gas which can cause extreme irritation, unconsciousness, and even death. Chinese drywall was found by Lawrence Berkley National Laboratories to emit hydrogen sulfide up to 100 times greater than non-Chinese produced drywall. Hydrogen sulfide is a hazardous gas which, in high concentrations, can be fatal. According to Dr. Patricia Williams, a University of New Orleans toxicologist, highly toxic compounds have been found in Chinese drywall and prolonged exposure to these compounds can cause serious problems. Strontium sulfide (another gas that is emitted from Chinese Drywall) may be dangerous to developing children; it affects bone growth. **Chronic exposure to these gases may affect the central nervous system (including visual and sensory changes), cardiovascular system, eyes, kidneys, liver and skin.** Infants, children, the elderly and the infirm (particularly those with heart and lung disease and diabetes) and pets may have an increased vulnerability to these gases and the particulates that are released from the drywall.

Health risks may remain an open question, but homeowners exposed to Chinese drywall often report similar physical ailments and symptoms including acne, asthma attacks, bloody noses, congestion, coughing, problems, hair loss, headaches, hives, irritated eyes, joint and muscle pain, miscarriages, nausea, nosebleeds, phlegm, rashes, runny nose, shortness of breath, sneezing, sinus problems, sore throat, tightness of the chest, trouble breathing and urinary tract infections after being exposed to Chinese drywall.

Warning Signs:

- A rotten egg smell within the home
- Corrosion or blackening of metal items within the walls or protruding from the walls, and
- Homes built between 2004 and 2006
- Complaints from home owners in line with the effects of the Chinese drywall
- Find an area where back of drywall is exposed (i.e., attic, garage) and look for the words "CHINA", "KNAUF", or C36 stamped on the back or edges of the tape.
- Go look at a number of electrical receptacles and copper wiring along with the A/C coil for black corrosion.

Gulf of Mexico Seafood Should Not be Eaten

New Orleans, LA - "The fishermen have never seen anything like this," Dr Jim Cowan. "And in my 20 years working on red snapper, looking at somewhere between 20,000 and 30,000 fish, I've never seen anything like this either."

Dr Cowan, with Louisiana State University's Department of Oceanography and Coastal Sciences **started hearing about fish with sores and lesions from fishermen in November 2010. Some of what she says:

- **Essential fatty acids** help to push aluminum out through your hair, believe it or not. **Omega 3 oils** are essential for brain function. Fatty acids also lower blood pressure. Apparently, good sources of essential fatty acids are **flax seed oil, evening primrose oil, and krill oil.**
- **Fluoride [causes you to absorb more aluminum](#) that you come into contact with and aluminum can cross the blood-brain barrier, causing Alzheimer's and short-term memory**

loss as mentioned earlier. Studies show a [5-15 point reduction in IQ](#) associated with fluoridation.

- When aluminum ions and magnesium ions combine they clot the blood. A good blood thinner is **ginger root** (capsules) **Ginko Biloba & the enzyme Nattokinase**, although do not take these if you are already taking a blood thinning medication/pharmaceutical. That would make your blood too thin.
- For heavy metal removal you can use **diatomaceous earth** (**make sure it is food grade**). This all natural substance and binds itself to heavy metals to allow release through bowels.

It is second only to fetal tissue. Russell L. Blaylock, MD, **estimates that annual radiological breast exams increase the risk of breast cancer by two percent a year. Over a 10 year period the risk will have increased by 20 percent**
